CONDITIONS OF MEMBERSHIP:

I. I agree to be bound by the conditions of:

- Constitution, rules and guidelines of the Friends of the Wingecarribee Animal Shelter Inc. (FOWAS).
- Fundraising Authority Number CFN18658 issued by the Office of Liquor, Gaming and Racing.

I agree that I may be suspended or expelled from FOWAS should I act in an unethical manner, bullying or harassment of another member/volunteer and not limited to the below examples:

- Abusive or offensive language, insults, ridicule, sarcasm or intimidating remarks
- Spreading derogatory innuendo or rumours about a person
- Physical aggression
- Making phone calls or sending letters or e-mails that are threatening, abusive or offensive
- 2. I declare that I have not been convicted of charges relating to domestic animals.

Should any member breach any of these conditions, membership can be terminated by the committee and become effective immediately by a letter in writing to the applicable member.

Please note:

- A member is not entitled to vote at any general meeting of the association if the member is under 18 years of age.
- Membership depends on your application being accepted by our committee. This hapens at either the monthly committee meeting or a general meeting, if your application is received after these meetings it may not be accepted until the following meeting month.

FOWAS MEMBERS CODE OF CONDUCT

- A FOWAS Member must act honestly, in good faith and in the best interests of the organisation as a whole.
- 2. Each FOWAS Member has a duty to use due care and diligence in their work.
- 3 A FOWAS Member must work in the best interests of the organisation as a whole and be mindful of all relevant laws, policies and procedures relating to their role.
- A FOWAS Member must not make improper use of information acquired as a Member.
- 5 A FOWAS Member must not take advantage of being in the position of a Member.
- A FOWAS Member must not allow personal interests or the interest of any associated person to conflict with the interest of the organisation.
- 7 A FOWAS Member should not engage in conduct likely to bring discredit to the organisation.
- A FOWAS Member has an obligation, at all times, to comply with the spirit, as well as the letter, of the law.
